This notice is to advise you that the following pesticides will be used at Pascack Valley Regional High School

Fipronil	Termidor SC Termiticide- Insecticide	7969-210
Imidacloprid	Premise Foam	432-1391

Location of the pesticide application: Hallway wall and doorframe of room 179

Reason for the pesticide application: Termites

Date and time application is planned: DATE 5/14/21 TIME 1:00pm

If an outdoor application, 3 dates must be listed, in chronological order, on which the outdoor application may take place if the preceding date is canceled; and the time the application is scheduled to occur.

Description of the possible adverse effects of the pesticides as per the Material Safety Data Sheets for the pesticides to be used, if available:(Termidor) HARMFUL IF SWALLOWED.HARMFUL IF ABSORBED THROUGH SKIN. HARMFUL IF INHALED. Causes eye irritation. Acute toxicity: Slightly toxic after single ingestion. Slightly toxic after short-term skin contact. Slightly toxic after short-term inhalation. Irritation I corrosion: May cause slight irritation to the skin. May cause moderate but temporary irritation to the eyes. (Premise Foam) Harmful if swallowed. Avoid contact with skin or clothing. Wash thoroughly with soap and water after handling.

Pesticide product label instructions and precautions related to Public Safety. Note: as required by law, we are advising you of the following statement: (Termidor) Harmful if swallowed, absorbed through skin or inhaled. DO NOT get in eyes, on skin or on clothing. DO NOT breathe spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco. Remove and wash contaminated clothing before reuse. This pesticide is toxic to birds, fish, and aquatic invertebrates. (Premise Foam) Remove all sources of ignition. Avoid contact with spilled product or contaminated surfaces. Isolate hazard area. Keep unauthorized people away. Harmful if swallowed. Avoid contact with skin or clothing. Wash thoroughly with soap and water after handling.

*The Office of Pesticide Programs of the United States Environmental Protection Agency has stated:
"Where possible, persons who potentially are sensitive, such as pregnant women, infants, and children, should avoid any unnecessary pesticide exposure."*

REMEMBER: Whenever a non-low impact pesticide is used on school property there is also a Restricted Entry Interval (REI) that begins when the pesticide application ends. This Restricted Entry Interval last for seven hours unless the product label uses NUMERIC LANGUAGE, e.g., 4hours or 12 hours; directing a longer or shorter period of time. If the product label does not discuss Restricted Entry the period of time defaults to seven (7) hours.
