# Title: Continuum of Services for Gifted and Talented Education Act

#### Preamble:

The Continuum of Services for Gifted and Talented Education Act is designed to ensure that gifted and talented students have equitable access to appropriate educational opportunities that meet their unique learning needs and support their intellectual, social, and emotional development. This act recognizes the importance of identifying, nurturing, and challenging gifted and talented students to help them reach their full potential. It is our commitment to provide a comprehensive and flexible continuum of services that caters to the diverse needs of gifted and talented learners.

#### **Section 1: Definitions**

1.1. **Gifted and Talented Student:** A student who demonstrates exceptional intellectual, creative, artistic, leadership, or other abilities and requires specialized programming or services beyond the standard curriculum to fully develop their potential.

### **Section 2: Identification and Assessment**
